

REQUIREMENTS FOR DRIVER'S ED

***MUST BE 14½ YEARS OLD (TO THE DAY) OR OLDER BEFORE HE/SHE CAN SIGN UP FOR DRIVER'S ED

***YOU MUST RESERVE A TIME SLOT AT THE DRIVER'S LICENSE DEPARTMENT TO GET YOUR PERMIT ISSUED. THIS WILL ENSURE THAT YOU WILL BE SEEN BEFORE CLOSING. IF YOU DO NOT CALL FOR A SPOT, YOU WILL NOT BE ALLOWED TO SIGN UP. (208) 878-1108

The student should complete the *Driver's Training Information Sheet* including the medical conditions portion. If a student has one or more medical conditions listed, please obtain a Medical Examination Certificate from the Driver's License Department for your doctor to complete. Please bring the completed medical examination certificate with you on the day you come to purchase your Driver's Education Permit.

BOTH PARENT AND STUDENT MUST BE PRESENT TO SIGN THE STUDENT UP FOR DRIVER'S TRAINING. Natural Parents/Legal Guardian or Adoptive Parents with court documents can sign the student up for class. Parents, bring your driver's license or state ID for identification.

REQUIRED DOCUMENTS:

1. ORIGINAL STATE CERTIFIED BIRTH CERTIFICATE ISSUED BY THE BUREAU OF VITAL STATISTICS: This certificate must be the **STATE ISSUED** document only (not the hospital birth certificate with foot prints or the 3½ x 5 temporary birth certificate issued at birth). Idaho Transportation Department and the State Department of Education **WILL NOT** accept any birth certificate without a State Seal. If the student was born in any foreign country, they must have legal presence documents, i.e. – passport with English VISA, INS card, etc.
2. PHOTO IDENTIFICATION: An identifying photo with student's name is required. A school activity card or yearbook is acceptable. A valid Passport or Military Dependent ID is also acceptable. No other ID's are acceptable.

REQUIRED DOCUMENTS (CONTINUED):

3. SOCIAL SECURITY CARD: The original social security card needs to be brought in.
4. **VERIFICATION OF COMPLIANCE LETTER (VOC)**. A letter from the school stating you are compliant and able to sign up for classes. **WE CANNOT SIGN YOU UP WITHOUT IT.**
5. NAME CHANGE DOCUMENTS: If there has been a legal name change from that which appears on the birth certificate, the supporting documents must be present along with the birth certificate. Step-father's name will not be included on the driver's license.
6. LENSES: If corrective lenses are required for distance vision, please have your glasses or contacts with you when you come. You **MUST** pass a vision screening.

Once you have passed the driver's training class there will be a period of 6 months that must be driven. **(This time starts from the time the class ends, not from the time the permit was issued)**. Fifty hours, 10 of which must be done at night, must be completed with a licensed driver over the age of 21. At the end of the 6 months, when your 50 hours are completed, a written test and road test will be required before a driver's license can be issued.
