RENEWING YOUR CREDENTIAL FOR 4 YEARS ONLY?

You can renew by mail if:

- ❖ You are between the ages of 21 and 69
- ❖ You are a US citizen or permanent resident
- ❖ You are renewing an Idaho class D driver's license or ID card
- ❖ Your driving privilege is valid
- ❖ You are not adding an endorsement
- ❖ You are not changing to a Star Card
- ❖ You are not changing your name

Please allow 12-14 business days from the time ITD receives the application
